Presentation of New Business: MOTION: "That future pressings of the A.A. Service Manual include blank Group Change, and New Group forms on the last page of the service manual." Teddy BW, District 06. (Friendly amendment: pressings to printing). Now reads: "That future printings of the A. A. Service Manual include blank Group Change, and New Group forms on the last page of the Service Manual".

Discussion: The intent of the motion is so that new or changing GSRs have a blank form on hand to report to the GSO. We passed this with substantial unanimity at our district. **Q.** Was it ever considered to put a link to those PDF forms on the GSO website? **A.** No **Q.** Was consideration given to the fact that most of us use a small print format of the service manual? **A.** Not specifically. **Q.** You did say the last page of the service manual, so are you suggestion it be in a specific place? **A.** Correct **Q.** You are proposing then that pS29 remain as it is, and that a new blank form be added at the end. **A.** That is correct, and we actually do have a blank page at the end of the current service manual <<Chair asked for a simple majority to leave at ACM or to take to Assembly Business: Vote: Assembly -23 Area -26.

This will be new business at the next ACM. >> *(See What's on your mind notes on last page.)
OLD BUSINESS: NONE
Discussion Topics:

1. Recovery, Unity, and Service - What are our responsibilities? How do we fulfill them?

I think the service piece leaves us lacking for whatever reason. When it comes time for people to make themselves available for various jobs, we seem to have a lack of people interested. Many positions remain open because no one is available. Perhaps that is not emphasized as much as it should be; it is probably a sponsor/sponsee situation. I emphasize service with my sponsees and I think it is a part of the program. I'm not sure whether this is becoming a greater problem. We make ourselves available not because it's fun or convenient, but because they need to be done. If this organization is to continue to exist, then we need to have people stepping forward and making themselves available.//It is generally suggested that someone be asked to resign if they do not fulfill the responsibilities: who does that and are we indeed doing it?//I hear frequently that General Service is considered politics. We should not try to preach to someone but to listen to them. What are we doing to make them feel that way? When I first came into the program, my perception of the steps was different than my experience.//We have exactly that situation in our district. The district created an alternate so as not to confront the absent person or to have an uncomfortable district meeting. When someone isn't here to make a vote, we don't have representation. Often, the solution is from the heart.//Some of my PRAASA notes center on unity and what I understand is that unity is the continuation of AA as we know it. "Diversity is unity"; "We are a fellowship of deeds, not creeds", 'We are here to save drunks, not souls": these I heard at PRAASA and it's about humility. I may be the only form of unity or humility that some see so it's up to me to act that way if possible.//I like to do lots of different things and my sponsor told me to focus on one thing and to do it well. I hope I am an example of a GSR and what a GSR should be. If that's all I can do, then I think I'm doing a good job.//Every month we have a speaker meeting which may not seem like a lot to you but it is to us in a rural community. We get 100 or more and we also have a 10 min service speaker: instead of talking about what service has done for his sobriety, they reduce their recovery story to 10 mins instead of speaking of service.//I'm practicing participating as part of my responsibility. We all have responsibilities. It is my responsibility to make that decision. I check my traditions checklist and see if it's a need. It's okay to say I can't do this and support someone who might need another outlet to better serve AA. We have to support each other that way.//Responsibility teaches me to respond. How to step back and be present and available when needed is part of my responsibility. 2. Benefits of living in the heart of AA service work: I've learned how to do things I never thought I could. It's a great place to let go. I see things that appear crazy to me, but I let it go. Watching people grow is amazing. Privilege of being a service sponsor is a classic way of learning by teaching. It's been amazing. Forming great relationships is wonderful. Car pooling: amazing discussions. Overcoming fear: getting in front of a group of people has helped. I've also been able to travel to other parts of the country.//It has opened up my sobriety: an alcoholic alone is bad company. I've gotten back into the middle of the

herd.//If there's a little pitter patter here, don't leave with that. Go to the mic. One of the benefits has been to slow down. It makes me appreciate other areas of my life. You've taught me to lighten up because I can be very serious about things.//I truly think I have learned everything I have about love and tolerance in service. I thought I was going to get love and tolerance at the Conference and I learned that there were people there I didn't like. I witnessed someone serving AA and I learned about love and tolerance. I do not see eye to eye with a board member in AAWS: we can learn from those whose opinions are different and we can learn from them.//We have a lot of service positions at my meeting. Service keeps me coming back. My sponsor lives in service work. My sponsor has taught me to give honestly of myself. We're here to help. We want to give.//One of the benefits is the miracles. I attended the NCCAA. I was driving and thinking of what I can do to help another person I love. I texted my friend who doesn't want to come to meetings and she responded. It makes me feel I am in the right place.//A lot of meetings I go to want nothing to do with service. Trying to talk about Gen Service there is hard. Whether I reach them or not, it's if I reach them to stay in AA.//I've been coming here for a little over 2 years. This is my first time at the mic. BTG came in and Debbie D was there and she took me aside and she talked to me and she gave me a list of three things to do and I did. I came into service quickly. I came to a pre-conf assembly without knowing where I was going and that was a spiritual awakening. I got involved and boom, boom, boom, here I am. I've been told by you all how to do that. It provides passion for me. It keeps me sober. From PRAASA: a coffee maker who rec'd compliments and then rotated out and the new coffee maker rec'd compliments.//Rule 62: my worst problem is listening to my head. I was convinced I was the worst DCMC in the history of AA and I was convinced of that and people told me I'm doing fine. My head is not the most reliable source of information. Don't take yourself too seriously, no one else does.//When I was rotating out of being a coffee maker, there was an opening in my group for a GSR and when I started it was a totally new experience. I saw a whole new part of AA, a unity I didn't know was there. I connect with people when I work on projects.

WHAT'S ON YOUR MIND?

Here we're proposing to make a change to our service manual that will effect AA as a whole and we are keeping it here. I'd like to see more discussion before we have a vote. if we send something to NY without area weight it will not have the same effect.//What goes to assembly versus what is here; sometimes as a GSR I get overwhelmed and we have a lot going on at the assemblies anyway. I know that my DCMC/DCM will bring something back and carry our

conscience here. We don't always have to get everybody involved all the time; sometimes I am too overwhelmed as a GSR.//I have a sponsee who sends texts and I refuse to text. She puts a new spin on things. I would probably change my vote at this time.//I'm confused and that's not unusual. So, on that motion, I was under the impression that if we talk about it at the area level, then we can bring it to the assembly.//A good friend of mine passed away. He would always go to the mic and he would always tell a joke. I would cringe. He was always there for me. I wanted to share that with all of you.//I don't want to come here and start arguments or correct anyone but the thing that got me and kept me here was the minority opinion after a vote was taken. Today it was almost 50-50. I was taught when I came in here that that close a vote merited more consideration. A minority opinion was asked for and no one gave it. If I had heard it I might have changed my vote.//I am here to remind you to bring your fm radios.//Thanks to all and all the work they do. I love PRAASA and the panels. I am so glad that I found service in CNCA. The simultaneous translation and summaries are so helpful.//Q. Would you consider a motion to revote on the motion? A. Yes, that can be considered).//It would be nice to purchase a banner with the 12 concepts (29.00/ + shipping) The room looks empty without it.//I have been so moved by all the discussion I have heard here. I really can look in your eyes and know that you are doing the best job you can in supporting me. I can think of a face and know you are there for AA. We don't do this alone./I still have a couple of conference reports left to schedule. I will send you emails. I've learned to live no longer in fear or that I am not good enough, but to live in faith; it is such a wonderful experience. I would like to thank our La Viña friends for visiting. They have made great efforts to attend PRAASA, our meeting, and the NCCAA conference. I will do my best to serve you.

*After the discussion, chair decided to revote the motion for new business (re: future printings of service manual) by simple majority, to go to assembly or stay at Area. Vote: Assembly -29; Area-19. Abstention-1.

Standing Committee Reports: Quarter 1, 2014

We are continuing our work on several projects. Our project of reorganizing the Archives Repository has been going well. This will help to locate information within the repository, as well as help to protect documents by minimizing handling when doing research. We are continuing to work on our new displays. We have been working on putting together a bid for the National AA Archives Workshop in 2016. The committee has had displays at AA events including NCCAA. We look forward to bringing displays to upcoming events such as District Unity Days. (Laura Wh, Archives Chair)

Bridging the Gap has been busy! In the first quarter of this year, our districts have had 108 presentations with 443 requests for contact. We had another Chair Orientation this quarter with a lot of participation. We had many members participate in PRAASA and enjoy their first BTG roundtable. We held a sharing session the past 2 months on the Agenda Topics from Treatment & Special Needs regarding the BTG Pamphlet and Corrections around the video "Sure beats sitting in a cell". (Claudia N, BTG Chair)

We presented a housekeeping motion to increase the delegate's out-of-pocket Conference expense reimbursement to \$1300, which passed. Our discussion topic about increasing the amount CNCA sends to AAWS to help cover the delegate Conference costs continues, we encourage districts and sub-districts to discuss and possibly bring a motion forward. 2013 tax returns are being prepared. We review the monthly financial reports and housekeeping requests for money. We collect money at area meetings and assemblies and help send receipts to groups for their contributions. Next quarter we will start the 2015 budget process. (Jennifer B, acting Finance Committee Chair)

The Interpretation and Translation Committee is working on translating the motions book. Discussing the ASL service we provide at the post-Conference Assembly and the CD we record. We are concerned that this service is not being used or not advertised enough. Eliminating this service could save \$400 - \$600 a year. Waiting for input from the districts. Looking forward to interpretation of the joint workshop of the standing committees at the April ACM. (Richard H, Interpretation and Translation Chair)

The PI/CPC Committee hosted a speaker workshop in January. We spent two months gathering group consciences on Agenda Topics. We prepared for the joint PI/CPC, BTG, H&I meeting. The attendees of the CPC roundtable at PRAASA unanimously and enthusiastically requested CNCA to host a training session for the Pacific Region.
