# PREVIEW OF THE AREA COMMITTEE MEETING

# June 2014

Hello fellow members of California Northern Coastal Area (CNCA),

At the last Area Committee Meeting we had three discussion topics. A discussion topic it is not a motion. However, please share it with your Districts and Groups, and get their feelings on the topic. This ACM was the last discussion that we had about; should we have a standing policy when we have excess funds to increase the amount we send to AAWS to help cover the costs for our Delegate at the Conference each year? But we will continue discussing the following topics:

- 1) Should Area officer travel be limited to every other month- Visiting even districts on even months and odd districts on odd months?

Discussion Topics:

- 1. Should we have a standing policy when we have excess funds to increase the amount we send to AAWS to help cover the delegate Conference costs each year?
- 2. Should Area officer travel be limited to every other month, visiting even

districts on even months and odd districts on odd months? Officer could be requested on off months. Area officers are eyes and ears of the delegate; area is so large, delegate cannot visit all. Officers assist the Area.//Dist proposed a motion last panel: part of the rationale was to make the job of area officer accessible to more people; socioeconomic pool seems to be where our officers come from. We are hearing from job descriptions that there is need of a great deal of time and effort to serve; so our version was to have districts have the prerogative of officer attending.//I spent 7 hours looking at motions book to see why the officers visit us: for us, for the Area. Past chair told me it's so the delegate has a sense of the area, to keep delegate informed. Gave me a new light: delegate has a pulse of the whole area.//I was part of that discussion way back when. Each officer is the eyes and ears of the delegate. We have one of the best informed areas: we have contributed so much because we have great communication here.//I looked at the down sides of the alternating months; there were so many questions. We are well informed and get to communicate with each other and see GSRs grow. Some concerns about work load of officers are legitimate. Maybe we need to revisit to have alternates and share the workload. Other areas now do visits and think it's great. They share the work load a little differently. We share our summaries with over 60 areas in the US and Canada: at the conference we are experienced and informed. People asked me why I went so much to the mike and it's because I heard you: youtalked about stuff no other area discussed.//Now that I've heard that this is a reporting situation, I feel it's one-way. Maybe some feedback would be great. We should know what's being reported to our delegate. We need to be as well informed as the delegate.//My sponsor told me to sit and listen when I visited a district. I thought about this last panel when districts would say we don't need an officer: we've been delegated to serve the area. We elect committee chairs, speakers at assemblies, and people to write pros and cons: we come to know our members better than the districts.//There's a lot of discussion about why we go: we can hear, we can help, we can get to know each other. Communication is valuable; it facilitates this. If we reduce an officer's requirements by ½ I'd personally save maybe 8 hours a month. I go to other things I don't have to attend but choose to. Reducing our travel is insignificant. If someone is strongly committed to doing the job, we get better area officers.//A personal GS inventory: am I doing my job? #12: Am I responsible for having the best informed group or dist? Keeping them informed: my job is to enable them to make informed decisions.//The idea of an alternate may have some negative aspects./I'm hearing that we are a victim of our own success. I thought everyone did it like we did; they don't. A huge thank you to our area officers. If it's not a pain in the butt or at least inconvenient, there's no spiritual value. We have made an impact. Every year there is something in the agenda topics that comes from CNCA. We have something special here and I would like to see us keep that. It takes a special person to make themselves available to do the job.//I love dist visits and I'm not an area officer. I love to see the differences and the camaraderie. I still think this might work. Every other month might be enough; we won't know until we try.//This might be good monetarily but sometimes good is the enemy of the best: (Bill W).//When I took on a responsibility I knew I had to do it: I also believe if you had the damn money to go get loaded every day you can drive to Santa Barbara//At dist level we don't have enough time, so I can't imagine what it likes to an Area officer: I can imagine what it would be like to lose the connection. It's a spiritual conduit. Visiting officer motivates GSRs to attend area: people come back thanks to officer visits.//The one argument that gave me pause last panel was the contact the area officer had with the dist. It should be the individual members.//One of the DCMCs last panel couldn't get the time off from work to become an officer. In 1988 we were still using pagers; gas was \$2/gal. This panel is different: we can contact via the website, but I need to access it or contact an officer.//My entire life changed when I committed to serve. Things went south at my last mtg: I had someone from the area who was there to discuss that, who saw it happen. Every other month would not have provided that opportunity. Stressful or not, it's important.//Face to face is the best form of communi-

cation.//I am the rec sec at my dist; I have to write what the officer says. I put it in the report. It's spiritual: a GSR can be motivated. When you see the effort officers put in to do service, it's a motivator. If they go every other month, this will not be seen by members//I like participation of officers: it motivates me to come to the Area: I see an officer; my sponsor is a DCM and goes to the Area; now I realize the GSRs are the ones who

I didn't see anyone using the service and we spent 700 on it. I've been asking for 5 months; no one responded. I don't mean to not provide a service but to save money and provide if requested//l've rec'd feedback from two deaf people in our dist. Neither is interested in service: so said it's not needed.//One person requested a CD, so I look at the entire communication we have with deaf/hard of hearing. There is a need for this kind of service.//From the last topic, I was thinking of Bill Wilson asking if this service is needed. For our officer travel I think it's needed, but the translation was \$350 per hr for two hours and then we had to pay transportation, etc. I wonder if it is needed? Requesting in advance might be appropriate.//\$700 sounds expensive, but its a special service. Maybe we should make this available for other areas.//lisn't there an app that would be speech to text that would be cheaper? Let's look at alternatives: there's an app for everything.//lsn't there a cheaper way?//Why do we just provide it at only one assembly? Is it the only assembly where anything important is discussed? It's all written anyway: maybe the energy would be better used at the preconf.//In D40 we have an ASL meeting. I think we need it. Why not record our delegates' report and have the recording translated IF requested? I don't think it need be done simultaneously//I am responsible: it's not about how much it costs.//As this exists now we are required to provide this, no if ands, or buts. My problem is tradition 5: when we spend a lot of money to provide a service for 0 alcoholics. I can think of better ways to spend our money. We asked prior to Assembly if anyone wanted it. No one responded. Live interpretation is expensive. Make it available IF requested: modify the motion. Speech to text apps exist.//I got to sit up close at the Assembly and was happy to see the interpreters and shocked to see they were translating for each other. I think the operative word is reaches out; if no one requests we should not do it.//l've heard a lot about having a written form. A lot of deaf people don't speak English: ASL is not English.//The main issues is we can't recall any request for the recording. I was told to not listen to the words as much as the feeling; interpreters do transmit feeling, but we aren't hearing that people want this.

# **DCM SHARING SESSION**

Presentation this month was made by Robin M. District 14 – "Some Ways to Keep Our Home Group Safe."

Robin started her presentation reminding us of the Long Form of Tradition One. Finding a balance between the individual expression and the group safety, emotional and physical is the question. In the climate of safety it is about protection people both from being injured and from causing injury. Our lives and recovery are at stake. Physical Safety can include stalking, unwanted 13th stepping, violent and threatening behavior. Emotional Safety It can include stereotypical language, humor at the expense of the individual or the group and "advise" (cross-talk). When thinking about physical and emotional safety remember Tradition 10 (outside issues) and Tradition 5 (primary purpose). Some approaches toward safety in the group can include greeters before and after meetings and phone lists to the newcomers and visitors. 13th stepping can be approached with members of the group surrounding newcomers and those who tend to engage in 13<sup>th</sup> stepping before and after the meeting. Active sponsorship and watching our own behavior would also be personal ideals for us as individual in the group. Regular Group Consciences and Inventories on this also would make the group aware and individuals comfortable with having this discussion with others. Addressing appropriate behavior in the meeting format and workshops around safety would also empower the secretaries/chairs on ways of dealing with behaviors and suggestions to all about defusing potentially violent situations. Robin also listed additional resources: Box 459, fall 2010, AA Grapevine September 2013, Reprint of Bill W's "Who is a Member of Alcoholics Anonymous in the Language of the Heart page 37. Leadership in AA: Ever a Vital Need reprinted in the AA Service Manual, Concept IX and the 62<sup>nd</sup> General Service. Safety in AA: Our Common Welfare from April 2012.

Within our sub district we have some disruptive behavior. Most times someone can get the meeting back on track but other times it can get very uncomfortable.

Thanks for the resources.

Shoes were being thrown at our business meetings. We started using a format at the meeting and are learning through that to have safe discussions. It is working well for now.

We have a steering committee meeting every week. We bring the issue out in the open and fall back on our traditions for help.

Most issues are handled by the secretary, but one group is having trouble with the secretary's behavior. They are now working on a solution for that.

Be sure that the greeters for the group are safe. Some can be a little forward.

Thanks for reminding me of this.

Anonymity is also a safety issue, such as taking behaviors to outside authorities. Phone numbers can also cause harm if used incorrectly. Workshops from the districts would be great.

Some at district level just don't like General Service. We have found that the more we pay attention the louder it gets.

We need to be more aware of members' behavior and be comfortable in correcting this and bringing it out into the open.

Adding something to the format of the meeting helps. It reminds members to be aware of their own behavior.

Restraint of body movements can be added to pen.

Some members are not comfortable with "hugs". We need to be respective to their boundaries

Choosing trusted servants is also important to safety of the group. Consider safety issues when choosing secretaries and General Service reps.

I don't spend a lot of time thinking about this. AA did not guarantee me safety.

I gravitate toward members in meetings that do not show this behavior.

I like the pro active solution you have given. Talking about this brings it all out in the open.

Reference to leadership and Concept IX helps with safety issues. Training GSR's to handle this will help them to be able issue at group level. I think it is great for us to talk about this. It helps promote unity to the groups' and AA as a whole.

Talking about this in the open helps educate members and groups. Seeing this all together helps me see this better. This is something we can confront. I am going to bring this up at our sub district meeting.

Next month "How can we better serve our "Special Needs Members"?" Presentation will be done by Mariann G. District 4.

# **ASSEMBLY BUSINESS MEETING MINUTES FOR MAY 2014**

#### CALIFORNIA NORTHERN COASTAL AREA ASSEMBLY BUSINESS MEETING MINUTES 2014 POST-CONFERENCE ASSEMBLY

The Assembly Business meeting of CNCA was held May 10, 2014 at Redwood Empire Fairgrounds, Ukiah. The meeting was opened at 9:12 by Raymundo L, followed by the Serenity Prayer. The AA Preamble was read by Steve N of Dist 10. Brian K of Dist 10 read the Traditions in English and Francisco M of Dist 20 read the Traditions in Spanish. Presentation of New Business: NONE

OLD BUSINESS:

MOTION: "That CNCA06 submit a request to delete 'of the opposite sex' from p117 in the book 'Twelve Steps and Twelve Traditions'." Discussion: We talked about this and there was great excitement. Overwhelming majority in favor; the minority was afraid of changing words.//It's important to a newcomer to feel included//Strongly support the motion: the context of the phrase is nearly every sound human being: it writes me out of the program to read it the way it is written. Same sex marriage is an outside issue.//Unanimously in favor.//Unanimously in favor: it will make this book more inclusive.//Majority said of course as long as no complete republishing. After discussion, several people discussed the precedent of changing wording in either BB or 12/12. Concern was about keeping an open mind and getting over the discomfort of the wording when working with a sponsor.//Group was agreed about the inclusivity of this proposal but a minority who is Bible oriented said this is the tip of the iceberg, but no one changed vote.//There was a discussion of whether the 12+12 should be changed. Same sex marriage has been an issue. This raises a question of the violation of traditions. Some people might not be bothered: they're in AA. I'm more concerned about those who are not in AA. The service manual changes every year. When the 2002 Conference affirmed the language in the Twelve and Twelve, same sex marriage was not the political debate it is today; now that it is a divisive political issue. AA literature should step outside of political controversy, and this minor deletion falls in line with Tradition 10 in not endorsing or opposing one form of marriage or another. Also, gay people who are sober may not struggle with the sentence the way it is now; however, gay people who may one day find the rooms of AA should not be turned off by a passage that can so easily be edited, and falls in line with Bill Wilson's intent//lt's a good idea to delete these words. I gave rides to a gay woman. She had to carefully choose her words when sharing.//Since this is a guide for every AA member, if someone has the need to find a partner does it have to be of the opposite sex?//Having been harassed because of my sexual orientation, and since we are a gay and LBGT Area I would love to see unity on this issue.//You have to read the entire paragraph as a compliment to that step. If I identify all of the small sentences in the steps (atheists, for example, if I start personalizing, I have to take it into my conscience.//Thank you for bringing this forward. Since this is being discussed for the first time, I'm hearing a lot about gay marriage: I hope we can continue to look at Step10 and look at Step 1: our common welfare coming first. Not the political scene, but the right thing to do for our membership, not to be controversial.//At first I was in support but I'm looking at it now and is I continue reading it, there is more that is mentioned that is not typical of relationships now. I don't think there is a need to replace the 3 words.//All humans at some point have strong desire to find a partner. If we change we have to go further back in the writing in the paragraph and change it too. We should not change it.//It takes 75% of the groups to change. We need to investigate to see if there is other movement to change. It's not just us.

**MOTION:** "That future printings of the AA Service Manual include blank Group Change and New Group forms on the last page of the service manual." District 06

**Discussion:** Changing] this form is unnecessary. I have been requested to make changes for the Area. The format in the manual is a small size. An

8"x11" paper is easier to use and scan.//l don't feel the need; You have to register yourself and you get the form from the registrar or download. Not necessary to spend the extra money//lf we provide that form, anyone can register a group and many groups that are not part of our traditions are being registered and we will have no control. We need to know if the group is really a traditional group//l think it's not very practical.//lt's available on line.//l think having the form would make it a lot easier to do on the spot registration.//lt would encourage people at the district level to go out and find GSRs and register them at the same time.

Discussion Topic: How do we keep GS relevant to 12 step work and for the alcoholic who still suffers?

I think it would be very helpful if we had time at some point to allow people to share his/her recovery story and share that this is in fact AA.//I love that we have this discussion topic. As alternate DCMC I facilitated an orientation and I tried to talk about direct and indirect 12 step work, so for me what we do here is relevant to 12 step work and for the alcoholic who still suffers and it gives me faith that all that we do will have an impact.//When I was home with debilitating headaches I could still take time to work with sponsees and work with my service sponsor to keep connected with AA. To be welcomed back is the best feeling ever: I've never had an experience like that.//So much of what we do in GS is thinking inside the box. We look at what we can change and these come up as motions. Should maybe we have some discussion before hand to see how this will benefit the alcoholic who still suffers? Should we be thinking of the alcoholic who does not come to these meetings? A lot of time it falls off the table. Discussed before hand would help//GS is relevant to me for 12 step work. It shows our members that it's relevant. If you're not sure, take away the BB and print something for us//I have learned to be open to the minority opinion. It has helped me learn and pass it on to the next person.//If there was no GS there might be no Daily Reflections. If there was no GS office there would be no archives to store the stories.//12 step work is important facilitate GV&LV are tools for the newcomer. Corrections and for those who don't have H&I.//Assembly covered 12 step covered agenda topics. I learned more about GS.//We've been unregistered for a number of years and we learned we were not being served; being registered helped: it would behoove us to get the information out as to how GS can help us. Our group is now thrilled to be registered, to be heard. We learned that GS is how we speak to the conference. // One alcoholic talking to another face to face: group knows GSR who is related to the ghost of GS. I took our sec to a GS meeting and now she has had our officers come to share their stories and now GS is seen as one alcoholic talking to another face to face. Things are starting to shift//This topic is relevant to me. I do my best to become more engaged in GS I know how important it is to reach the alcoholic who still suffers through GS: I am the first one in 16 years who has brought info to my group: many members have no idea what GS is. When I gave a report and told them how their discussion of agenda topics was delivered and heard, they were interested. This is very real as are our service committees.//At some point GS works for the guy who has not yet been born and that made me more enthusiastic. I don't do much of what someone would call for face to face12 step work. I participate: someone told me he is glad that AA is enhanced by GS. We are really doing 12 step work.//About 30 yrs ago I asked someone to be my sponsor. She was a GSR and took me around: I'm still here and that's how GS works.//One of the things that made me realize our importance here. I don't get an opportunity to do one on one 12 stepping, but this is the same thing. We all have a positive effect on AA//If this alcoholic does not participate I will revert back to the alcoholic who still suffers. There is so much out there that extends beyond our person and our home group.// It's changing the projectory of my recovery and my life.//Personal experience: I heard a woman walking around talking to herself. She was angry and distraught, lay down on a bench and fell asleep. I realized I was responsible and everyone ignored her. Manager was going to call a cab. I talked to her, shared who I was and what I did: that is my first time to talk to a wet drunk: a very spiritual experience.//GS is relevant; not a question what is: How do we show? This is part of my recovery. I see the enthusiasm and the opportunity to be of service: it's attraction rather than promotion. I think it's a matter of showing how we work, how we appreciate.//Keeping focused on how we get in touch. I think this is a continuing trend: we are listening and focusing on our basics. Are we really in touch with our membership and can we do that more? We need to spend the time to make connections with our groups. As we look at our themes we will see how this works.//We need to talk about GS

functions at our groups that have to do with 12 step work. We need to equip our members with knowledge and the ability to share that: describe to our members how they can participate in those services that are relevant.

"WHAT'S ON YOUR MIND?"

The courage to stand up and not walk away has also served me recently. It was suggested I bring up my expenses to my group: it is being increased fourfold. The group now respects GSR and the value of what we do.// Preliminary final attendance: 218 voting,116 non-voting 334: above avg for a post-conference. Thanks to the registration crew.//I want to personally invite all to the summer assembly in Vacaville. It will be over the top. Wear your boots, hats, and gingham: Aug 9.//Thanks to all who came here and all the volunteers that came forward to make this happen.//Contributions today 1540.80 Thank you.

Pro argument for the CNCA Motion:

That future printings of the A.A. Service Manual include blank Group Change and New Group forms on the last page of the service manual."-District 06

GSO Service Material (SMF 104) states, "To participate in services provided by G.S.O. to A.A. groups, it is vital to furnish simple information to G.S.O. through the Alcoholics Anonymous New Group Form." Making it easy for groups to link with AA as whole is critical to the well being of AA. If AA groups are to hold "the final responsibility and ultimate authority for AA world services," as stated in Concept I, it is of paramount importance that all groups have easy access to the forms that link the groups to AA as a whole.

Yes, these forms can be found on-line. However there are AA members who do not have easy access to computers and/or the Internet. Access to technology should not be a barrier to participation in AA. Further, although these forms might be obtained from Registrars or other Committee Members, many AA members must travel great distances to meet with others in their District. Blank forms in the back of the Service Manual would also serve as a convenience for groups that operate remotely. The forms currently found in the Service Manual (S29-S30) are filled out, to serve as examples -- making reuse impractical. Providing additional ways to have access to these forms may increase the number of groups registering and/or updating their information. Widening access to these forms will only make it easier for groups to link to AA as a whole. As Tradition One informs us, "We stay whole, or AA dies."

Pro argument for the CNCA Motion:

" That CNCA 06 submits a request to delete "of the opposite sex" from p117 in the book "Twelve Steps and Twelve Traditions."

In regards to the motion to remove the phrase "of the opposite sex" from page 117 of the book Twelve Steps and Twelve Traditions, I am writing in favor of removing the phrase.

The first and most obvious argument is that the phrase in context of the very human desire to engage in a relationship with another person was written at a time when "of the opposite sex" may have been considered a widely accepted phrase that assumed inclusion of all people. In the subsequent decades, with the great strides in civil rights, we now know that this phrase can be viewed as exclusionary. AA is inclusive. AA Tradition Three: "Our membership ought to include all who suffer from alcoholism."

Secondly, do not think that the proposal is just an act of political correctness. The request is modest, well timed and strategic. Gay rights and marriage equality has been a growing concern at all levels of society. Therefore, this civil rights discussion will continue to be a prominent topic for the long term. Because of the ubiquity of the issue, this simple antiquated phrase has become a lightning rod, distracting alcoholics into the political climate. It is distracting alcoholics from the deeper question posed in the text immediately following the phrase, of how an alcoholic in the grip of the disease may by ignorance, compulsion, and self will have misused the gift of a deep loving relationship. The removal of the phrase will bring us back to the real message of the text, that "Nearly every human being experiences, at some time in life, a compelling desire to find a mate with whom the fullest possible union can be made - spiritual, mental, emotional and physical. This mighty urge is the root of great human accomplishments, a creative energy that deeply influences our lives."

In removing the phrase "of the opposite sex":

- \* We will be an inclusive fellowship following tradition.
- \* We will remove a distraction from recovery.
- \* We can continue to carry the deep, clear message of recovery for all alcoholics long into the future.

Con argument for the CNCA Motion:

That future printings of the A.A. Service Manual include blank Group Change and New Group forms on the last page of the service manual."-District 06

Cons: It's not practical because for most people the first step is to register as a new GSR, and you can download the form from the AA website. Besides, if we provide this form then there will be groups using it to register (or change) and sending directly to GSO instead of to the District or Area Registrar and it will be months before the info filters back to us.

This is an unnecessary change, the print is so small on the existing forms in the Service Manual so it's unlikely that many people will actually use it. The District and Area Registrar's are important positions in our service structure, providing the blank forms will deter people from contacting their District or Area which means we could potentially miss an opportunity for a person to person contact, thereby denying someone the experience of being of service.

Con argument for the CNCA Motion:

" That CNCA 06 submits a request to delete "of the opposite sex" from p117 in the book "Twelve Steps and Twelve Traditions."

It is difficult to find any tremendous downside to the proposed motion of removing the phrase - 'of the opposite sex' – from p.117 of the text *Twelve Steps and Twelve Traditions*. I do respectfully and lovingly challenge however our slight tendency to focus on individual and singular conceivable changes to our conference-approved literature. Perhaps we in CNCA could instead facilitate increasingly broader discussions that circumvent the potentially disconcerting effect of our [arguably] predominantly heterosexual and patriarchic-themed recovery literature that underpins the motivation for the discussion of this motion. Respecting too that our time together as a CNCA body is limited - we must ascertain whether discussing these individual and singular changes to our basic texts is the best use of our resources [time + money] in terms of maximizing our contribution to the Conference's overall goal of reaching as far and wide as possible to still-suffering alcoholics.

We must too consider that [according to our tenth tradition] Alcoholics Anonymous has no opinion on outside issues. Arguably the '12 x 12' text expresses an opinion on an outside issue by presuming that mates only choose other mates of the opposite sex. When we discuss at CNCA deleting the phrase 'of the opposite sex' in the 12 x 12 to remove its subsequent heterosexual connotation we are yet again expressing an opinion on an outside issue. Consequently we face a conundrum. If as a CNCA body our group conscience voices a strong concern to remove all predominant heterosexual and patriarchal themes in our A.A.W.S. literature we would arguably need to make extensive and sweeping changes to not only our 12 x 12 – but as well to the first 164 pages of the 'Big Book'.

However to focus too discriminately on any one page, paragraph, sentence, phrase, and/or word has its repercussions. We restrict the development of a group conscience that addresses the larger potentially problematic nature of our texts' outdated cultural biases and the possible negative affects these may have upon still-suffering alcoholics of the 21<sup>st</sup> century who won't [not so loving-ly] stand for it.
